- Les Mills Asia Pacific (LMAP) reserves the right to postpone or make changes to training dates and/or times should extenuating circumstances arise, or insufficient registrations be obtained.
- Non-refundable travel bookings are made at the risk of the attendee and LMAP bears no responsibility for any loss of funds.
- The cost of training is inclusive of all resources and video certification. This is a non-negotiable amount that remains unaffected by already possessing Instructor resource kits.
- If you are unable to attend the module, written notification must be received at LMAP prior to the commencement of the module. If unforeseen circumstances should arise, waiver of the cancellation fee will be at the discretion of LMAP.
- All cancellations will incur an AUD\$100.00 cancellation fee and must be accompanied by an original medical certificate. No refund or credit is available after the course has commenced.
- If you do not have a Cert III/IV qualification, LMAP recommends that you complete GEL and an LMAP module training together. Note that GEL qualifications are the minimum requirement for Industry Group Fitness employment. GEL is a non refundable course.
- Your place in the training modules will only be confirmed after your payment has been successfully received.
- For those participating in their first Les Mills training module there is an element of "assumed fitness industry knowledge". Each participant is required to learn and present their tracks.
- It is a requirement that you attend the training module in its entirety. Adequate time needs to be allowed overnight to learn tracks.
- Participants will need to bring adequate food, water, footwear, clothing and towels, as there are physical components to the training modules.
- You will need to bring a CD Discman or iPod to listen to your music throughout the training. (if you bring an iPod you must also bring a laptop to download the music). Participants will learn different tracks throughout the training.
- At the commencement of the training participants will be required to sign the Deed of Understanding acknowledging acceptance of all terms and conditions.
- Participants will need to inform both LMAP upon registration and the trainer on the day of any physical restrictions, disabilities or injuries.
- LMAP advises that all Instructors attending Les Mills training modules, should register with their state fitness body before teaching group fitness classes.
- Les Mills Asia Pacific Group Fit Formula(s) are only to be taught in a Les Mills Licensed Facility.
- All transfers and credits will incur an AUD\$50.00 administration fee. Credits and Transfers are only granted for medical reasons with an original medical certificate.
- Age limits apply for all training modules (16 years of age and above).
- If after completing training you are required to re-sit day 1 and 2 of the module, a fee of AUD\$100.00 is payable. Re-sits must be completed within 6 months of the initial module training. If not completed within this time frame you will be required to sit the entire module at full price.
